

**CITY OF THORNDALE**

**ORDINANCE NO. 2020-04**

**AN ORDINANCE PRESCRIBING SEWER UTILITY RATES PROVIDED BY THE CITY OF THORNDALE, TEXAS, AMENDING ALL APPLICABLE ORDINANCES AND OTHER INSTRUMENTS IN CONFLICT; PROVIDING FOR SCHEDULE OF SEWER RATES; PROVIDING A REPEALING CLAUSE; ESTABLISHING AN EFFECTIVE DATE; AND PROVIDING A SAVINGS CLAUSE.**

**WHEREAS**, it is the purpose and intent of this Ordinance to adopt new sewer rates, fees and charges for such utility provided by the City of Thorndale; and

**WHEREAS**, this Ordinance amends all prior Ordinances or other records to establish new sewer rate fees as provided herein.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF THORNDALE:**


**SECTION 1.0** Exhibit "A" attached and incorporated by reference into this Ordinance, establishes fees and charges authorized by the City Council for sewer utility rates.

**SECTION 2.0** All fees and charges specified in Exhibit "A", shall be in effect on the September, 2020 billing cycle.

**SECTION 3.0** All Ordinances and records in conflict with the provisions of this Ordinance are hereby repealed.

**SECTION 4.0** If any sentence, phrase, paragraph or other part of this Ordinance is held to be invalid by a court of competent jurisdiction the holding of invalidity shall not effect the remainder of this Ordinance and all portions of this Ordinance not held to be invalid shall continue and remain in full force and effect.

**PASSED and APPROVED** on this 8<sup>th</sup> day of July, 2020, by a vote of 4 "Ayes" and 0 "Nays" with 4 members of the Council present and voting.
