ORDINANCE #2022 - 03

AN ORDINANCE OF THE CITY OF THORNDALE, TEXAS, REPEALING ORDINANCE NO. 2013-02 (MUNICIPAL COURT TECHNOLOGY FEE) AND REFERENCING IN PLACE THEREOF THE TEXT OF ARTICLE 102.0172 OF THE TEXAS CODE OF CRIMINAL PROCEDURE AS IT READS EFFECTIVE JANUARY 1, 2020; REPEALING ORDINANCE NO. 2013-03 (MUNICIPAL COURT BUILDING SECURITY FEE) AND REFERENCING IN PLACE THEREOF THE TEXT OF ARTICLE 102.017 OF THE TEXAS CODE OF CRIMINAL PROCEDURE AS IT READS EFFECTIVE January 1, 2020; CREATING A LOCAL TRUANCY PREVENTION AND DIVERSION FUND; CREATING A MUNICIPAL JURY FUND; AND PROVIDING SEVERABILITY AND REPEALER CLAUSES AND WAS ADOPTED IN AN OPEN MEETING.

WHEREAS, S.B. 346 has created a Local Consolidated Fee Amount which is chargeable and collectable by statute; and

WHEREAS, the Local Consolidated Fee Amount is made up of fees to be deposited into four separate funds: Municipal Court Building Security Fund; Municipal Court technology Fund; Local Truancy Prevention and Diversion Fund; and Municipal Jury Fund; and

WHEREAS, the repealed fees will now be collected under the new state law instead of city ordinance.

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF THORNDALE, TEXAS, THAT:

- SECTION 1. All of the facts recited in the preamble to this Ordinance are hereby found by the City Council to be true and correct and are incorporated by reference herein and expressly made a part hereof, as if copied herein verbatim.
- **SECTION 2.** To comply with S. B. 346 a Local Truancy Prevention and Diversion Fund was created to be maintained as a fund and account of the City of Thorndale.
- SECTION 3. To comply with S.B. 346 a Municipal Jury Fund was created and maintained as a fund and account of the City of Thorndale.

- **SECTION 4.** The Municipal Court Technology Fund account shall remain a valid fund and account for the City of Thorndale.
- **SECTION 5**. The Municipal Court Building Security Fund account shall remain a valid fund and account for the City of Thorndale.
- **SECTION 6**. The Security Fund shall be administered by and under the direction of the City Council.
- **SECTION 7.** All provisions of any Ordinance of the City of Thorndale, Texas, in conflict with the provisions of this Ordinance shall be, and the same are hereby repealed, and all other provisions not in conflict with the provisions of this Ordinance shall remain in full force and effect.
